September Regional Director Report

<u>Member comments:</u> If you ever want to address the board about a topic, please know that every third Friday of the month at 11:30am the Board of Directors dedicates time to listen to members. E-mail me for the ZOOM link and show up at 11:30am.

On August 19th I attended the August Board of Directors meeting in person at MAPE headquarters in Shoreview, MN.

I represent all of you at the MAPE Board of Directors each month. A by-law change voted on during the August meeting will affect this process. In the past, if a Regional Director was unable to be at the monthly meeting, they were able to send their President (or another local officer) as a replacement. After August's meeting, a Regional Director will no longer be able to send a replacement to vote in their absence. I voted against this change but was outvoted. Members can always view the Board meeting (except closed sessions). But going forward, if a Regional Director is absent, that region will not have a vote on the motions being considered at that meeting.

Lauren Siegel, Organizing Chair, stated it is crucial we recognize that it's an important time in our union. A new initiative being spearheaded by the Organizing Council is "MAPE-tober." This initiative looks at a MAPE member taking a week off in October and each day engaging in a different activity. One day could be political engagement, another day an organizing/recruitment event, and another day could be a workplace issue campaign to name a few. Locals could decide to do another month instead of October, although one of the suggested activities is political and the elections are coming up on November 8th. The Organizing committee plans to make this an annual event. The quick timing of this may make it hard for some agencies to do this, but we should plan to work this into our year for 2023 at minimum. MAPE was previously headed by an executive director. After the MAPE Executive Director resigned a little over a year ago, MAPE has been headed by two Interim Co-Executive Directors. The Governance committee is looking at a possible Chief of Staff position to replace the Executive Director. The union representing MAPE staff is providing feedback on this currently.

Interim Co-Executive Director Leah Solo informed us about upcoming elections. There is a lot at stake 74 days from today when we vote on governor and both houses of the Minnesota legislature. The MAPE endorsed candidates can be found at the MAPE website.

The Negotiations Survey was sent out on August 8th. This is earlier than past years. Encourage members to keep the responses coming. The Negotiations team is working on finding what people want in listening sessions throughout the state right now.

Delegate Assembly is coming up on October 8th. The committee is working on confirming details for the virtual event. DA resolutions were due today. The BOD asked for the resolutions be prioritized like they were 2-3 years ago. On-line resolution forums will be September 20 (12-1pm), September 21 (5-6pm), September 27 (5-6pm) and September 28 (12-1pm).

A draft 2023 MAPE Budget was present to the BOD by Statewide Treasurer Jorgenson. The draft budget will be presented at the Budget Forums on August 30th (5-6pm) and August 31 (12-1pm). Feedback from these sessions will be used to modify the final draft of the budget which will be presented for approval at Delegate Assembly on October 8th.

In the past, MAPE had been facilitating quarterly special elections for positions that were open in each local. This is being re-evaluated and there will not be a special election until 2023. Open offices should be handled by appointment until the next special election in 2023.

The Organizing Business Agents and the Enforcement Business agents have now merged. Going forward we will call them Business Agents again ②. The merger is going well according to Leah and Angie Halseth, our Vice President.

MAPE is using a new IT vendor—Sovereign. The transition is going smoothly.
