    - iv. Also thank you to Randy Gjerde for representing us at the last negotiations. There is a person from Local 1901 who has accepted a nomination for the coming negotiations cycle.
  - b. Vice President's Report Jocelyn Crist
    - i. There will be negotiations coming up for disability and life insurance rates. They apparently haven't been negotiated in quite a while.    Topics included PERB board?, state funding, legislation, and our CATS? Rights. Effective communications tools to inform out members better.
- 2. Presentation by Union historian, Peter Ratcliff. He's available to come to our meeting for a presentation.
- 3. There were many member comments at this board meeting. Mostly they were vocal about wanting MAPE to sign a petition to divest in companies that fund Israel.
- Comments copied and pasted from the chat feed -
- What is the purpose of mentioning the protesting? Are we being encouraged to do so??
- Our retirement is in investments that fund military companies to the Isreali government
- Should that be up to the individuals to individually move their investments?
- So we can't individually move our investments?
- Our pension investments are controlled by the State Board of Investments https://msbi.us/
- My question is where does the special interest end? It feels like a Pandora's box, and a potential slippery slope.
- Question from the audience Are there people on the other side of this issue in support of Israel? Answer: There are some board members have the opposite perspective, but they are in the minority. Most of the members who spoke are Jewish.
- Comments from Matt Potocnik He wants to be respectful of peoples opinions on the Palestine/Israel situation. It is a very charged issue. However, Matt wants to focus on what unites us as a local. It's important in our local meetings to stick to the issues that are pertinent to our local. If you have questions, comments, or concerns that you want to share with MAPE contact Nicole or MAPE central directly.
- Nicole adds that there are a lot of people asking MAPE to make a statement, but the central office has not made that decision yet.
- Also, come to a monthly board meeting. There is always time set aside for member comments. It is a finite amount of time. So if you would like to make comments contact Nicole a couple of weeks beforehand so you can get on the agenda. Otherwise you may not get a chance. You can also call in to the board meetings to comment. You don't need to be there in person.

- 4. A colleague support network is being created This program is geared primarily toward support of our members in the Department of Corrections as well as some Department of Human Services members who have very high stress jobs. They are in the implementation stage of this program. More to come. There is an 85-page document available. You can contact Nicole if you would like to see it.
- 5. The ERC presented at this meeting. They won't be doing Steward training days at headquarters any more. They want to come to the locals. Question - Are there any specifics coming out about how the steward training will be coordinated? Answer: There should be something coming in the newsletter.
