- Last Meet & Confer with Exec Team March 13th, 2024
  - Listening Session overview recognition and communication
    - MPCA MAPE Meet and Confer Committee provided an overview of the input MAPE members provided during last fall's listening sessions on recognition and communication to management
    - See meeting notes on MAPE's website for full details
    - Management was receptive to our suggestions and heard the input provided. We are looking forward to continuing conversations and real improvements.
  - Student Loan Reimbursement Policy overview provided by HR
    - MPCA has developed a draft student loan reimbursement policy available to share
    - Reimburse eligible employees for already incurred student loan payments.
    - Up to \$5,000 per calendar year per eligible employee, up to \$25,000 in total payments.
    - There is currently \$235,000 budgeted for the first round. Future amounts are not yet set and could increase or decrease.

- Tentative deadline to apply October 31, 2024 (application not yet available)
- To be eligible, an employee must have been employed by the state for at least 18 months (this timeline is different depending on what union represents the employee)
- If you receive a student loan reimbursement you must remain employed at least 1 year after receiving a reimbursement payment or pay back a prorated amount.
- If the available funding is not sufficient to reimburse the total requested amount, MPCA has developed a draft list of conditions to consider.
- Meet and Confer developed a FAQ available to share

- In response to our ask for additional career development at the agency, HR
  offering the "Let's Connect" series. Next event is today, May 14th, and focuses
  on Individual Development Plans (IDPs).
- MAPE vacancy on Safety Committee! Please reach out if interested in joining.

- Student loan survey to be sent out
- Listening sessions on student loans, hybrid work environment. Looking at lunch, before, and after work opportunities.
