- Our member percentage has dipped, but our membership is growing overall. We're just having trouble keeping up with the pace of new hires, so please reach out to new hires in your units!

4. Budget Update

- How do we get a budget?
 - o Formula
 - # members x \$1.25 x 26 pay periods = local funds per year
 - Crisis funds
 - MAPE has about \$12,000,000 in the crisis fund to help pay for certain things during a strike
 - Carryover
 - We want to use our funds in a good way and spend our money more to come on this in future meetings
 - We continually have between \$13,000 \$16,000 leftover each year
 - Doing good on budget, predicted to spend another \$9,050 total on upcoming lunches, membership prizes, and charity donations for the rest of the year
 - Potential about \$13,000 left in the budget again (\$10,000 if we pass the stipend vote!)
- Our budget status
 - o Carryover

- Projected to be about \$13,000 and if the local stipend passes (and every officer opts in), then about \$10,000
- o Dividends
- Ideas for modification vote next on local officer stipend

5. Stipends for Local Officers

- We hope this will help recruit members to serve as local officers
- We are able to offer stipends to local officers, but it has to be approved by the membership
 - Only local officers are allowed to receive a stipend.
 - Each local officer may receive a stipend equivalent of up to \$480 maximum/calendar vear.
 - Stipends shall be paid out on a yearly or 6-month timeline as decided by the local officer team.
 - Meeting minutes (or approved local budget showing stipends) must be sent to the MAPE Financial Specialist.
- Only local officers are allowed to receive a stipend to account for the use of personal time and incidentals that come with the position of being a local officer.
- Stipends are considered taxable income and are subject to withholding taxes.
- Motion by Melissa Wenzel to approve the use of the stipends for local officers, per MAPE policy
 - Motion seconded by Charity Fretty
 - Motion passed


