- Met with MMB for the last round before Push Week

- Telework Proposal - MMB rejected and countered
  - Negotiations team rejected their counter
- Paid Parental Leave
  - Negotiations team rejected MMB request to reduce
  - Is the current paid parental leave benefit more generous than the new MN paid leave program?
    - Paid parental leave goes into effect after 1 year of state service i believe. PFMLA will be eligible to all MN workers regardless of 1 year or not
    - yes and it is also protected in our contract. The state paid leave program would be something that we rely on the state legislature to keep around and also fund
    - yes and they would stack. paid parental leave as we have it now is 100% of your paycheck for six weeks. Paid Leave through MN law would be up to 90% of your wages for a maximum of 20 weeks per year
  - MMB asking why we need Paid Parental Leave when we're eligible for MN Paid Leave is like saying we don't need pensions because we have Social Security benefits
  - There's a calculator on the Paid Leave site outlining cost <https://mn.gov/deed/paidleave/employers/premiums/>
- Chaplains Housing allowance
  - Progress on negotiating
- Professional Negotiator question
  - Folks in the roles are the best people to speak to what we need has been the traditional position
  - Typically members have been through the process a number of times and understand the process well
  - MMB is just very difficult to work with
  - Beyond the budget and mismanagement of SEGIP, is there any insights as to why there is such overtly outrageous proposals by MMB? Two years ago we were arguing between double digit percentage salary increases we would agree on.

- these increases are being proposed because SEGIP's consultant did a bad job of forecasting and now they want us to make up the difference.

## 4. RTO Discussion

- MNIT - same old platitudes and corporate speak from quarterly meeting
  - are you looking for more space?
    1. we are not in a position to comply with the 50% governor mandate
    2. allowed to get by with 20% for now as long as we have a plan to get to 50%
  - how are you improving morale during RTO?
    1. we want to hear from you how can we make spaces as meaningful, collaborative, productive as possible
    2. take out the question of should we do RTO? like a corporation, it has been decided for us.
    3. Tarek is reaching out to his peers for collab
    4. HR (Thuet) who relayed a conversation he'd had with Gartner, stating that they have data that after 6 months, any RTO shows increases in productivity
    5. belief that people don't feel a part of the larger group or have a sense of job satisfaction without in person interactions
- BWSR - It is noisy! Be prepared to be less productive. We don't have working equipment (ergonomic) at BWSR.
- My commute is getting longer by the day due to increased traffic
- It's been noisy with even just the supervisors and wifi has sucked around it.
  - with the 520 Lafayette building there are a few different wifi networks which isn't helping.
- Lots of people taking meetings without headsets, very distracting
- For some of us working outside of the border states, we received an original notice that our window to comply was by December. Now we've been told we have to comply by September 2nd.
- *How would RTO feel more inclusive?* I expect to still work. (???) And I would like to NOT have to "sign up" for a cube and have my own dedicated cube
- I'm a nursing mother and I'm concerned about competing for the room, or being able to get in to get the breastmilk and pumping supplies at the end of the day. Even with most folks not fully back, it is tricky with the one room and the fridge on the other side of the locked door.
- New(ish) parent here. The flexibility of being able to work from home more with a kiddo was CLUTCH for our navigating the early months. Even now with daycare drop off and pick up (and all the traffic), that 50% as full shifts in the office is nigh on impossible. Not to mention all the sick time that comes with new immune systems.
- I took a pay-cut to work for the state. The value I perceive to make it worth it are 1) decent benefits, 2) flexibility and 3) warm fuzzies of protecting my fellow citizens. 4) pension
  - 1) under attack in contract negotiations. Annual wage increases not matching inflation plus this huge increase in health care benefits is not acceptable.

- 2) I am attempting this through an ADA. but still, flexibility is under attack.
  - 3) continues unless we get "laid off"
  - 4) pension appears to be intact for now
- 1 & 2 being strongly challenged greatly reduced the value proposition offered by state employment. If we lose these things, we will likely never claw that ground back. So if we lose those, I'm likely gone anyways so we might as well strike.
- Flexibility is also one of the things that is attractive about state service (like somebody else mentioned earlier). I am trying to imagine what it will look like when school doesn't start until 9:30 and the kids are coming home around 3:30. Elementary-aged kid parents--what would this look like for you?

- ADA comment: "PCA seems to make it a bit more challenging from the start: 1) two almost identical ADA forms are to be filled out (why two forms?) and 2) the forms are required to be FAXED in (faxing is an inconvenience, but most providers should be able to accomplish this)."
- I did talk to ADA as I suffer from terrible migraines. Before COVID they removed a couple of the fluorescent lights above my cube. I was told that there is no need for that. Not exactly the response I expected.
  - That is the same person who yelled at us, while we were picketing, from his car.

Tentative Agreement (TA) made for a pilot program allowing people in VRS and SSB who are still on probation from reallocation (Those divisions have a reallocation career path so that is why the pilot is there) to interest bid on jobs while still on probation.

TA for some technical language changes

Held off management proposal to extend probation for the DDS division.

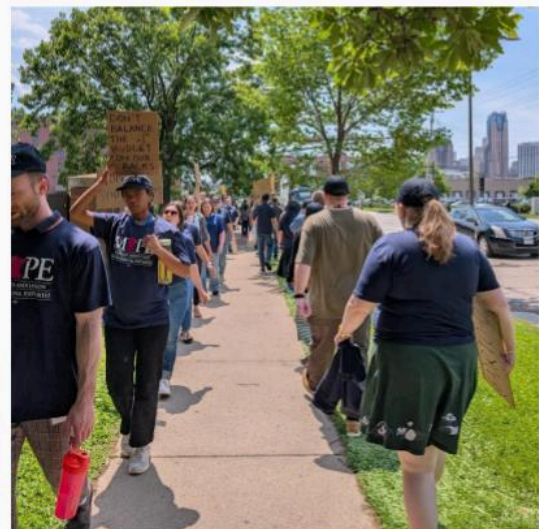
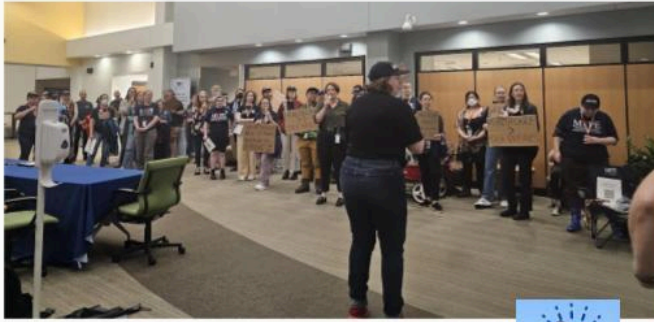
