

## 6. DLI Meet and Confer

- 1. Student Loan update (Alexis, 5 min)
  - 1. End of last year, met w/DLI management, put together a staff survey, had discussions w/other agencies about what they're doing, then the election happened. DLI has now declined to move any further with discussions of student loan project at DLI at this time. This is very disappointing we put a lot of time & effort into this process to be essentially strung along for about a year until they decided to stop engaging in any negotiations with us. DLI has been doing a lot of hiring in the last year, which has created a lot of questions about equity pay between new and long-time employees. MMB has a lot of control over pay, agency level has limited discretion things like student loan, achievement awards, but DLI is choosing not to use those. Frustrating, but we can organize around this issue. We just got a new M&C chair, so getting that going again. For agency-level parts of the contract, the rubber hits the road at M&C. Our power is in our people.
