- Negotiations started TODAY (April 11th, 2023)

- The State had <u>105 proposals</u> that they passed along (Walz was present for MAPE proposal presentation but not for the State) and there will be a more detailed update after tomorrow (first two days of bargaining)
- Healthcare will be negotiated separately

 - Our goal is to get as much action from membership as we possibly can
 - SIGN UP NOW! We're going to have a battle, so please sign on to the platform
 - They (MMB, administration, etc) still want what they want, they have budgets that will be in conflict with our needs
- Only members can vote on our contracts!

- Be ready to show up and do something about it (read your emails, sign up for the rapid response, tell us your stories)
