5. Board of Directors Update

- A special Board of Directors meeting took place on Friday, December 20th
 - The BOD discussed how to set up the Divestment task force approved at Delegate Assembly
 - Task force meetings are open to members, but announced one week in advance, so let <u>Mark</u> know if you'd like to get those invitations. Happening today January 14, this afternoon.

6. MPCA Meet & Confer Update

- Student Loan Reimbursement: 88 applications, 67 of which were MAPE
- Listening session: general themes and focus on safety
- Budget and Legislative priority updates from Management
 - Comms not able to share much
 - Current forecast: more spending at state level than originally predicted. Negative balance of -\$5billion at end of 2028. The total state budget is \$80billion.
 - Programs and services have had more people enrolled than initially anticipated.
- Room for more on this team! Not a huge commitment! Please consider getting involved!
- Questions from chat
 - Can you explain what topics for supplemental bargaining vs. main table bargaining are?
 - Naveen: Main table negotiations are in the contract renewal with MMB.
 Supplemental Bargaining is for PCA related improvements.
 - Kaity: Supplemental Bargaining is negotiating terms and conditions of employment that are specific to the MAPE represented employees in a

specific agency. Supplemental agreements can be found in Appendix G (pg. 186) of the Master Agreement.

- Main Table Bargaining is negotiating the majority of our contract (wages, health care, etc.) which provides the terms and conditions that apply to every MAPE represented State employee equally, regardless of what agency they work for. Most terms and conditions of employment are set forth in the Main Agreement. The Main Agreement is negotiated between the State (led by MMB) and the MAPE elected Regional Negotiators.
- Do you know when the Student Loan Reimbursement will go through, if we got it?
 - Kaity: Yes. here is the language from the MPCA's policy: "Approved recipients can expect to receive their student loan reimbursement payment within four to five pay periods following the close of the annual application period. Reimbursement payments will be on the employee's paycheck." The application period closed on Nov 25th 2024 this time.
- Will there be another round of student loan reimbursement this year? I couldn't apply this fall as I hadn't been working here for 18 months yet.
 - Michelle: my understanding is that it will be a once a year thing, as long as funding holds out. but reach out to HR, and see if they can make an exception.

 - In general, current forecast is showing more spending than originally predicted. If nothing changes, there will be a neg. balance of - \$5 billion at end of 2028.
 - State collecting less sales tax
 - More spending, increased costs of everything
 - Some programs/services had more people enrolled than anticipated (K12 education and long term support programs for people with disabilities, for example)
