

**MEMORANDUM OF AGREEMENT**

This Memorandum of Agreement (MOA) is made and entered into by and between the Minnesota Association of Professional Employees (hereinafter MAPE) and the State of Minnesota (hereinafter the Employer).

Whereas, the parties' reached a 2017-2019 tentative agreement which was subsequently ratified and approved by the legislature (the Agreement); and

Whereas, it was recently discovered that one grid in the Agreement (Attachment 1) relating to the Compensation for Customized Training Representative for 7/1/2018-6/30/2019 (Appendix E-2) is incorrect and the parties agree that it is incorrect; and

Whereas, the parties wish to memorialize their agreement that the correct grid is the grid in Attachment 2;

Now therefore, the parties hereto agree to the following modification to the MAPE Master Agreement:

1. The parties agree that the Grid for Customized Training Representative for July 2, 2018 through June 30, 2019 (Appendix E2) shall be replaced with the following Grid:






