- MOTION: Shanna Schmitt made a motion to approve the budget
  - Mark Snyder seconded the motion
  - Laura Millberg proposed amendments to the budget
    - Membership Awards/Prizes \$1,500; Donations/Goods & Welfare \$4,000; to Claudia's point, the budget should include what we would ask MAPE Central to supplement for union organizing activities
  - Laura withdrew the amendment
  - Mark Snyder membership is not as high as it should be the union exists to further the aims of the membership - there has been direction from MAPE Central to increase budgets for membership recruitment and engagement
  - Bill Dunn difficult to resolve with this many people suggest tabling
  - Mark Snyder we need to have a budget approved by the end of this year so tabling is not an option - but we can have amendments later
  - We are planning pursue funding from MAPE Central to increase our organizing budget
  - VOTE: No opposition, no abstention, MOTION PASSES
