

Res2024 MAPE DELEGATE ASSEMBLY RESOLUTION

Unspent Local Funds Recaptured

Whereas...

- There has been an increased focus and encouragement of Locals spending all their funds annually
- Locals have been frugal in the past because they've been worried about running out of funds, saving for the next fiscal year, and saving for strike efforts and support
- This has created an environment where Local funds aren't being used properly or effectively
- This has created an environment where Local funds aren't being depleted annually
- Local funds have 2 purposes, and only 2 purposes, they should never be carried over, as by definition, they are meant to be spent that year, and on those current members
- Locals will now have more funding if the "Increased Funding For Locals" resolution passes, the low-member Locals will not need to be singled out, but all balances will need to be accounted for as the fiscal year begins anew.

Resolved: Change the Funds Policy in the 'Local Supplementals' section to recapture unspent Local funds at the end of every fiscal year, deposit those funds into the Crisis (Strike) Fund, remove the language regarding Locals with under 200 members, and confirm all Locals are funded at the beginning of the fiscal year.

Any increase in Local Funds would mean (as it currently stands) no Local would need to worry about the amount of funding their receiving. As, if their funding was any lower, they would have so few employees, and so few members, they should be absorbed by another Local anyway.

Money will be used for operations of the Local in providing services to their members. A budget supplement may also be obtained by any local through a request to and approval by the Board of Directors' Finance Workgroup and the Board of Directors.	<ul style="list-style-type: none">Local Supplementals: All Locals with 200 or less MAPE represented employees shall have <u>account balances funds</u> replenished monthly up to with \$1000 if their balance falls below \$1000. <u>Funds are to be used for recruitment and engagement of members, and operations of the Local to that effect</u> Money will be used for operations of the Local in providing services to their members. A budget supplement may also be obtained by any local through a request to and approval by the Board of Directors' Finance Workgroup and the Board of Directors. <u>All Local funds unspent at the end of the fiscal year shall be transferred to the Crisis Fund.</u>
